# 48/09 Vandalism Report 20 March 2009 - 16 May 2009

# 49/09 <u>Licences – to receive an update and to consider and agree the future charges and payment options available for licence holders (Minute 475/08 refers)</u>

Consideration was given to the proposed costs and payment options for the issuance of licences to residents whose homes abut Langdown Lawn Open Space and Ewart Recreation Ground.

Members agreed with the payments terms and costs offered but asked that the licences include clauses to ensure that gates open into residents' properties and that the licence be transferred if a property changes ownership.

That options 1 and 2 for charges and payment options for the issuing of licences to residents whose homes abut Langdown Lawn Open Space and Ewart Recreation Ground be agreed and current licence holders consulted about the options available.

#### 50/09 Clayfields Sports Centre - Update (Minute 418/08 refers)

# 51/09 To consider a request for additional fencing at Noads Way Play Area

That the existing fence is extended by 30 metres along the rear of a property at Haynes Way at an estimated cost of £3500 plus VAT and that a request to fund the project is made to the General Purposes and Finance Committee.

# 52/09 Removal of play equipment - Fern Hill (Minute no. 390/03 refers)

It was agreed to investigate whether the change of use should be agreed with the District Council's Planning Department.
